We aim to inform you about your personal data processed by our Company.

1. IDENTITY OF THE DATA CONTROLLER

MOVE ON has the title of "Data Controller" in accordance with KVKK and relevant regulations in terms of personal data obtained from our valued customers. You can reach us through the contact information provided in Article 7 of the Customer Information Notice.

2. PROCESSED PERSONAL DATA

Within the scope of your relationship with MOVE ON, the following Personal Data is processed;

- (I) <u>Your Identity Information</u>: name, surname, TR ID number, ID sample/tax plate, signature, signature circular information,
- (ii) Your Contact Information: address, e-mail, telephone and mobile phone information,
- (iii) Your Payment and Financial Information: bank/account/card information, invoice/debit your information,
- (iv) <u>Business, Professional Life and Education Information</u>: your professional position, institution and title information,
- (v) <u>Customer Transaction Information</u>: customer order information, your sales information,
- (vi) User / Membership Information: user name, user password, location information of user devices, current status information regarding the user's field, your video and photo records regarding the user's field.

3. PURPOSES OF PROCESSING PERSONAL DATA

- Ø Execution of information security processes,
- Ø Carrying out communication activities,

- Ø Receiving customer orders and carrying out transactions,
- Ø Carrying out customer visits,
- Ø Execution of goods / service sales processes,
- Ø Carrying out the marketing processes of products / services,
- Ø Carrying out activities to ensure business continuity,
- Ø Carrying out financial and accounting affairs,
- Ø Carrying out activities in accordance with the legislation,
- Ø Execution of contract processes.

4. TRANSFER OF PROCESSED PERSONAL DATA

Your Personal Data; In accordance with the provisions of the Law regarding the transfer of Personal Data and within the personal data transfer conditions specified in Articles 8 and 9 of the Law, by our Company for the following purposes; It can be transferred to domestic official institutions and organizations, in-company teams and product/service provider companies for the following purposes:

- Carrying out activities in accordance with the legislation,
- Our company can share your personal data with our suppliers and service providers abroad, in

 application, and to carry out support and controls by providing the technical infrastructure
 for the services we offer, since the cloud system server we have contracted with is located
 abroad.
- Execution of contract processes.

In case of any dispute regarding the commercial relationship between you and our Company, or in case of a request from official authorities, judicial authorities or law enforcement forces, your Personal Data will be processed, primarily by the Code of Civil Procedure No. 6100, to the extent and limited to the relevant dispute/request. laws and secondary legislation such as

It may be shared with the lawyers and consultants from whom the Company receives legal support services, as appropriate.

5. PERSONAL DATA COLLECTION METHODS AND LEGAL REASONS

Your Personal Data is the information you transmit to MOVE ON verbally or in writing through different channels (hand delivery, electronic card reader system, mail or electronic mail sending) during our commercial relationship, and the information you transmit to MOVE ON through automatic methods (via the electronic systems and programs used by the Company). with) and/or non-automatic (by keeping physical files and records) methods, based on the following legal compliance reasons within the scope of Article 5 of the Law:

Ø It is clearly stipulated in the legislation to which our Company is subject, Ø It is

- necessary to process the personal data of the parties to the contract, provided that it is directly related to the establishment or execution of a contract, to be able to offer the requested products and services and the execution of the concluded contracts,
- Ø It is mandatory to fulfill the legal obligation,
- Ø Data processing is mandatory for the establishment, exercise or protection of a right,
- Ø It is mandatory to process data for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the person concerned.

6. RIGHTS OF THE RELEVANT PERSON WHOSE PERSONAL DATA IS PROCESSED

In accordance with the provisions of Article 11 of the Law, you have the following rights regarding your Personal Data:

- Ø Learning whether Personal Data is being processed or not,
- Ø Requesting information if personal data has been processed,
- Ø Purpose of processing of Personal Data and whether they are used in accordance with their purpose learning that it is not used,
- Ø Knowing the third parties to whom Personal Data is transferred domestically or abroad,
- Ø Correction of Personal Data if it is incomplete or incorrectly processed don't want.
- Ø Requesting the deletion or destruction of Personal Data,
- Ø In case of correction, deletion or destruction of Personal Data, requesting that these transactions be notified to third parties to whom Personal Data has been transferred,
- Ø Objecting to the emergence of a result that is unfavorable to the person by analyzing the processed data exclusively through automatic systems,
- Ø Requesting the compensation of the damage in case of damage due to the unlawful processing of Personal Data.



7. CONTACTING US FOR YOUR RIGHTS AND REQUESTS IF YOU WANT

In accordance with your legal rights stipulated within the relevant law and other legislation, your requests along with the documents that will identify you must be submitted to the petition (*i*) on behalf of MOVE ON TEKNOLOJI ANONIM SIRKETI, to the address Sanayi Mh, Teknopark Blv, No:1/4C / Z08 Pendik/ISTANBUL, with wet signature or by notary public. via or registered mail, or (*ii*) signed with registered electronic mail (KEP), secure electronic signature or mobile signature at moveonteknoloji@hs01_kep_tr_or (*iii*) to MOVE ON via these methods if separate methods are determined by the Board.

Applications to be made within this scope will be accepted following the identity verification by us, and your requests will be finalized as soon as possible and within 30 days at the latest, depending on the nature of the request. If the application is answered in writing, no fee will be charged for up to 10 pages, and a processing fee of 1 Turkish Lira may be charged for each page over 10 pages. If the answer to the application is given on a recording medium such as a CD or flash memory, a fee equal to the cost of the recording medium may be requested.
